EMPLOYEE APPLICATION & HIRING PROCEDURE

Under the department's selection system, applicants for the position of firefighter must undergo a background investigation that includes, but is not limited to, their habits, experience and character. **(ALL INFORMATION YOU REPORT ON THE FOLLOWING FORMS WILL BE KEPT STRICTLY CONFIDENTIAL AND WILL NOT BE RELEASED TO ANY OTHER AGENCY WITHOUT YOUR WRITTEN CONSENT.)**

It is necessary that the department has access to any information about you that may have a bearing on your suitability for employment.

TO QUALIFY FOR FURTHER PROCESSING, THE FOLLOWING ITEMS MUST BE APPROPRIATELY

COMPLETED IN INK, SIGNED AND DATED IN LEGIBLE FORM:

1. Completed, signed and dated application
2. Copy of your birth certificate
3. Copy of a high school diploma or certified copy of a GED certificate
4. Copy of your valid state driver's license.
5. The attached Waiver of Liability on Physical Agility Test, signed by the applicant and dated.

The above information should be completed, compiled together and attached to the application.

ALL ELIGIBLE APPLICANTS MUST BE CERTIFIED EMT BASIC OR HIGHER AND BE CERTIFIED

FIREFIGHTER I/II.

Eligible applicants that have successfully completed the application will be notified of a written test.

Applicants that have a passing score on the written will move on to the physical ability test.

The physical ability test is a Pass/Fail test.

Applicants that pass the physical ability test will then be scheduled to participate in the interview process.

After the interview process, the remaining applicants will be placed on the final hiring pool list at Centre Fire.

From that pool of applicants, the Chief and fire board will make the final decision on hiring.

The undersigned hereby releases and discharges Centre Fire Department, all agents, employees and officers of the Territory, from all actions and omissions, cause of action, damages, including acts of negligence and willful and wanton misconduct, claims and demands in law or in equity of every kind and character I may have, or my successors, assigns, heirs, executors or administrators may hereafter have against them or any of them, and hereby waive all claims against them or any of them resulting from any act, accident, or incident of any nature which may arise from my taking any or all of the physical agility tests as required and the department hiring procedures, state law or otherwise.
